DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

DUPLICATE

6-5/8" 20# 10-thd. New Seamless and Electric welded casing (75 joints Seamless, 50 joints Electric weld) was set in this well at 3756' and cemented by the Halliburton method with 100 sacks.

Casing and fittings were tested with 1200# pump pressure and allowed to stand undisturbed for thirty minutes. No drop in pressure resulted so the cement was then drilled out of the casing and the same test of 1200# pressure again applied and allowed to stand undisturbed for thirty minutes. No drop in pressure resulted so the drilling was then resumed.
