8-5/8" 28# 8-thd. New Electric Welded casing was set in this well at 2406' and cemented by the Halliburton Method with 500 sacks cement.

Casing and fittings will be tested with 1200# pump pressure and allowed to stand undisturbed for thirty minutes. Cement plug will then be drilled out of casing and the same test again applied and allowed to stand undisturbed for thirty minutes. If there is no drop in pressure drilling will be resumed.
