It is proposed to squeeze off lower Queen perforations to prepare this well for inclusion in the expansion area to the Eunice Monument South Unit. The perforations above 3600' will be above the unitized interval and must be eliminated. This work will be done by the following procedure:

1. RIH with bit and casing scraper and clean out to TD at 3865'.
2. Set RBP at 3600'.
3. Squeeze Queen perforations from 3254'-3574' with 250 sxs cement.
4. Drill out cement and retainer to 3600'.
5. Pressure test casing to 500 psi for 30 minutes.
6. POOH with RBP.
7. RIH with producing equipment and place on production pending assumption of operatorship by Chevron.
