Application of Continental Oil Company
for administrative approval of dual
completion in the Eumont Gas Pool and
the Monument Oil Pool of the Sanderson
A-11 No. 4, Section 11, T-20-S, R-36-E,
NMPM, Lea County, New Mexico

Gentlemen:

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 112-A of the Rules and Regulations of the New Mexico Oil Conservation Commission for the dual completion of its Sanderson A-11 No. 4 well, located 990' from the South line and 1650' from the East lines of Section 11, T-20-S, R-36-E, NMPM, Lea County, New Mexico, for the production of oil from the Monument Oil Pool and gas from the Eumont Gas Pool, and in support thereof states:

1. Applicant is operator of the Sanderson A-11 lease located in the SE/4 and the S/2 of the SW/4 of said Section 11.

2. Applicant drilled and completed on May 10, 1937, its Sanderson A-11 well No. 4 as an oil well in the Grayburg formation. Said well is in the defined limits of the Monument Oil Pool.

3. Applicant perforated the Queen formation in said well to produce gas through the tubing-casing annulus while producing Grayburg oil through two-inch tubing. Separation of fluids from the two pools is effected by means of a packer at 3630'. Two diagrammatic sketches of the dual completion are attached hereto, showing the formations involved, the interval of production in the Grayburg pay and perforated intervals in the Queen formation, location of the packer, and other information pertinent to the dual completion.

4. The Queen gas zone in said well is in the defined limits of the Eumont Gas Pool.

5. The well is equipped in such a manner that there is no commingling of fluids from the two common sources of supply and each productive zone can be tested separately in the well, as required by the Commission.
