FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

This request is to gain permission to centralize more than five wells into one tank battery on the above lease.

Wells # 2&5 on this lease are now making water and is necessary to treat. I have a treating plant at the battery serving these wells. I will only be matter of time until all the wells on this lease will be making water and I do not have a treating plant at the battery used by wells # 3 and 6, therefore, it is my desire to connect wells # 3 and 6, into battery serving wells # 1,2,4 and 5, which already has a treating plant. This battery contains 4-600 barrel wood tanks and if this request is granted I will add 1-500 barrel tank to this battery. I will save the cost of another treating plant, installation and operation during life of the wells.

This lease is drilled up, there will be no further addition of wells to the battery.

This request is in accord with my letter to you December 20, 1939, at which time I attached a plat of the lease.
