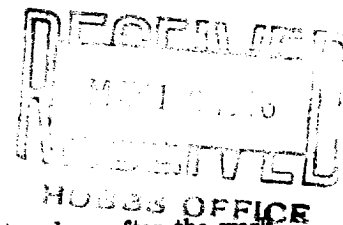

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED
3846' Plugged back depth; Pulled 3" EUE Tubing and took off Packer and reran 3" EUE Tubing and set at 3834' and ran 1" 1.70# Tubing and 5 Acme flow valves with Acme Packer set at 3815' and first valve at 1333' down, 2nd at 1828' and at 2323', 4th at 2820' and fifth at 3313'. Hooked up well with input gas and flowed for 24 hrs with input gas on 30/64" Choke made 81.4 barrels oil and 15.6 barrels of water, gross gas 355,775, input gas 249,000, net gas 106,775, Casing Pressure 550#, Gas Fluid Ratio 1,102 and Gas Oil Ratio 1,310.
