Figure 1. Schematic diagram of the experimental setup. The subject was seated at a distance of 60 cm from the screen. The screen displayed a target area (TA) and a starting point (SP). The TA was defined by a horizontal line and a vertical line intersecting at the center. The SP was located at the bottom left corner of the TA. The subject's hand was positioned at the SP at the start of each trial. The hand was moved towards the TA under two different conditions: (a) without visual feedback (no VF) and (b) with visual feedback (VF). The hand position was monitored by a video camera and recorded on the screen. The hand was stopped when it reached the TA or when the subject decided to stop. The time taken for the hand to reach the TA was recorded as the movement time (MT). The MT was divided into three phases: (a) acceleration phase (AP), (b) deceleration phase (DP), and (c) steady-state phase (SSP).
