DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

3865' Corrected Total Depth, Lime. Well was dead, pulled 2-7/8" OD, EUE tbg. and set Baker Magnesium Bridging Plug at 3713'. Tested 6-5/8" OD csg. with 1700# for 1/2 hour and no leaks. Ran 5-7/8" bit, drilled out bridging plug and cleaned out hole to bottom. Corrected total depth from 3864' to 3865'. Ran Dowell Spinner Survey and found fluid going into formation 3862'-3865'. Plugged back to 3850' with 184 gals. Dowell Plastic and 200# Ottawa Sand with 40 gals. plastic being dumped after sand was used. Ran Guiberson Hookwall Packer and 121 jts. of 2-7/8" OD, EUE, 6.5#, B-2, 10-VT, SS Tbg. SH, displaced water with oil and set packer at 3745', bottom tbg. @ 3841'. In 20 hrs. to 5:00AM, 8-3-48, swabbed 59bbls. fluid, 90% water.
