Acid was flushed with 30 barrels oil. Acid set 3 hours. Swabbed in and flowed 420 barrels oil on 15 hour test. Through 1" open choke on 2 $\frac{1}{2}$ " tubing. Hourly average of 28 barrels. Daily gas volume of 351,000' at last of test. Gas oil ratio 914. Tubing pressure 25#. Casing pressure 840#
