(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to shut off water as following:

- (1) Pull 2 1/2" tubing and packer and set cement retainer at 3770' on wire line
- (2) Run (& hydrotest) 2 1/2" tubing with stringer and engage retainer
- (3) Squeeze cement open hole below retainer and WOC
- (4) Pull tubing and perforate 7" casing from 3752' - 3764' with 4 bullet shots per foot. Acidize if necessary.
