FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

This well was temporarily abandoned on 11-24-59. The following cement plugs were set: 9300-9444 w/ 54 sacks; 8090-8250 w/ 60 sacks; 7600-7700 w/ 36 sacks; 7130-7230 w/ 36 sacks; 6830-7030 w/ 72 sacks; 6590-6690 w/ 36 sacks; 5350-5760 w/ 150 sacks; 5150-5060 w/ 35 sacks. The 9 5/8" Casing is set at 5124'. Top of cement is at 1050' behind 9 5/8" casing.

It is proposed to cut and pull approximately 1000' of 9 5/8" casing. Cement plugs will be set as follows: across top of 9 5/8" Casing from 950-1050 w/ 60 sacks; 277-377 w/ 60 sacks; and a 10 sack plug at surface. Marker will be erected and surface restored.

Permission is requested to perform the above work.

A subsequent report will be filed upon completion of this work.
