## FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

This well was completed 7-15-55 as a gas well producing from the Seven Rivers Formation. Water production has rapidly increased, and the well currently is unable to produce gas economically. It is proposed to permanently abandon this well and pull casing. To plug the well, a 50' cement plug will be placed at 3990', the top of the producing perforations; casing will be pulled and a 50' cement plug set at the top of the casing remaining in hole or at top of salt section, whichever is shallower. A 50' cement plug will be set at the base of surface casing, and the top of the surface will be plugged with a 20' cement plug. The surface will be leveled and location properly marked.
