- 6. Unless the non-standard gas proration unit, as requested herein, is approved by the Commission, Applicant will be deprived of the opportunity to recover its just and equitable share of the gas from the reservoir.
- 7. So far as is known to Applicant, the following constitute the only parties other than Applicant owning an interest in lands offsetting the proposed non-standard unit and such parties are being notified by registered mail of the proposed non-standard proration unit by the mailing of a copy of this application to them:
