March 7th ran 2" EUE x 4 1/4" Actual OD x 38" Exner Dodge Formation Packer set at 3775', two joints of 2" (62'1") anchor below packer with 5" perforations on bottom joint.

On March 8th, 1941 acid treated below packer with 1000 gallons Dowell X acid.

Production before setting packer & Acidizing:- Flowed on test, Jan 27, 1941, 46 barrels oil and no water in 24 hours thru 1/2" & 3/4" chokes with 960,000 cu. ft. gas GOR 20,900.

Production after:- On State test (GOR), flowed 41 brls oil and 3 1/2 barrels water thru

Witnessed by 1/2" choke wide open, gas 60,200 cu ft GOR 1,468.
