DETAILS OF WORK

Treated well with 1000 gallons Halliburton acid from 3765' to 3855' in Lime formation, through 2" tubing under 400 lbs maximum and 200 lbs minimum pressure. Reaction time 30 minutes. Flushed acid out of hole with oil and swabbed well. Well flowed at the rate of 4 barrels per hour on 6 hour test, 5/10 of 1% BS&W. Tubing pressure 150 lbs, casing pressure 1000 lbs. Gas-oil ratio 3250 to 1. Work performed by Halliburton Oil Well Cementing Company.
