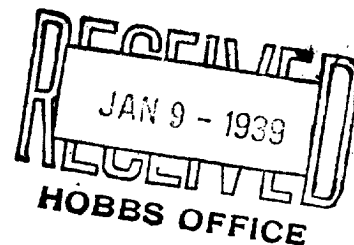

Figure 1. The effect of the initial concentration of the monomer on the polymerization of  $\alpha$ -methylstyrene initiated by  $\text{C}_6\text{H}_5\text{MgBr}$  in THF at  $-78^\circ\text{C}$ . The polymerization was carried out in a 100 mL three-necked round-bottomed flask equipped with a mechanical stirrer, thermometer, and nitrogen inlet. The monomer was added to the flask containing the initiator solution, and the mixture was stirred for 1 h. The polymerization was stopped by adding methanol.
