Pulled rods, pump and tubing. Made 2 runs with string shot opposite 7" casing perfs. from 3848' to 3940'. Run #1 - 100 grains per foot of pay. Run #2 - 300 grains per foot of pay. Ran sand pump and cleaned out to 3950'. Acidized perfs. with 500 gals. 15% reg. acid. Swabbed back acid water. Ran rods, pump and tubing. Resumed pumping. No change in producing status.

Prod. Test - 2-17-64 (Prior to workover)

Pumped 8.30 bbls. oil and 2.77 bbls. water in 24 hrs. on 11-48" SPM. GOR 8560

Prod. Test - 3-2-64 (After Workover)

Pumped 20.06 bbls. oil and 4.89 bbls. water in 24 hrs. on 11-48" SPM. GOR 5940.
