Ran 102 Jts and cut Jt (3763') 7" OD 20# Gr J-55 SS casing. Set and cemented at 3780' with 1500 sacks 4% Gel and 150 sacks Neat on bottom. Plug at 3745'. Maximum pressure 600#. Job complete by Howe 11:55PM 4-5-55.

After waiting over 24 hours, tested 7" casing with 1000# for 30 minutes. No drop in pressure. Drilled cement plug from 3745' to 3780'. Tested below casing shoe with 500# for 30 minutes. No drop in pressure.
