## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 8 Jts (310') 9-5/8" OD 32.30# Gr H-40 SS casing. Set and cemented at 323' with 275 sacks Regular Neat cement. Plug at 300'. Maximum pressure 225#. Circulated approximately 35 sacks cement. Job complete by Howco 11:AM 1-16-55.

After waiting over 24 hours, tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled plug from 300' to 323'. Tested below casing shoe with 400# for 30 minutes. No drop in pressure.
