FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production, it is proposed to plug back and fracture treat as follows:

1. Pull rods, pump and tubing. Run steel line measurement, if warranted clean out with sand pump.
2. Plug back to 3830' with Hydromite. Run 2-7/8" tubing with hookwall packer and hydraulic holddown. Treat formation from 3734-3830' with 10,000 gallons refined oil with 1# sand per gallon.
3. Block fractured zone with crushed mothballs in lease oil. Treat formation with 10,000 gallons refined oil with 1# sand per gallon.
4. Pull tubing, packer and holddown. Run 2-3/8" tubing and return well to production.
