By form letter dated April 5, 1956, The Texas Company was notified by Mr. R. F. Montgomery that in order to comply with Order R-553 it must obtain a connection or secure a no-flare order from the Commission for its Z. A. McNillan "B" Well No. 2. This action must be taken before June 26, 1956. As a result of this notification The Texas Company does hereby make application for a no-flare order for their Z. A. McMillan "B" Well No. 2 in compliance with Order R-553.

The Z. A. McNillan "B" Lease contains 160 acres and is comprised of the southeast quarter of Section 4, T-19-S. R-37-E, Lea County, New Mexico. The attached plat was prepared to show the location of the subject well, offset ownership, and the location of the tank battery. The Texas Company is in the process of negotiating a contract with Phillips Petroleum Company to take the approximately 63.4 MCF of casinghead gas per day now being produced and flared by the subject top allowable well, which produces with a gasoil ratio of 1720 cubic feet per barrel. However, due to difficulties being experienced by the gatherer in installing its gathering system it is doubtful that a connection for the Z. A. McMillan "B" Lease can be obtained in less than six months. Therefore, a temporary noflare order for a period of at least six months commencing June 26, 1956, is respectfully requested for Z. A. McMillan "B" Well No. 2.
