A plat is attached hereto showing to the best of Applicant's knowledge and belief the proposed unit, the location of the No. 1 well, and all offset wells and ownership thereof.

The granting of this application is in the interest of preventing waste and the protection of correlative rights.

In view of the facts set out herein it is respectfully requested that the Commission enter an order approving the proposed dual completion and non-standard provation unit both as prescribed above.
