for authority to effect a Monument
oil-Eumont gas dual completion on its
State A-7 well No. 1 located in
Section 7, T19S, R37E, Lea County,
New Mexico; and for approval of an
80-acre non-standard gas proration
unit consisting of the N/2 SE/4
Section 7, T19S, R37E.

Gentlemen:

Continental Oil Company, hereinafter referred to as Applicant, respectfully requests administrative approval under the provisions of statewide rule 112-A to dually complete in the Monument oil pool and Eumont gas pool its State A-7 well No. 1, located 1,980 feet from the south line and 660 feet from the east line of Section 7, T19S, R37E, NMPM, Lea County, New Mexico. A plat attached hereto shows the manner in which the dual completion is proposed to be accomplished. The Eumont gas will be produced through the tubing. The fluids from the two reservoirs will be completely separated by appropriate packers, and the well will be so equipped that the reservoir pressure of each of the two pools may be determined separately. Wellhead equipment will include all necessary connections to permit accurate measurement of fluids produced by each pool as may be required by the Commission.

Further, Applicant respectfully requests approval under the provisions of Rule No. 5 (b) of the Special Rules and Regulations for the Eumont gas pool, contained in Order No. R-520 of an 80-acre non-standard gas proration unit consisting of the N/2 SE/4 of the said Section 7 to be allocated to the said State A-7 well No. 1. In support of this request applicant would show that the proposed unit conforms with the requirements of said Rule 5 (b) in all respects as follows:

1. Said unit consists of contiguous quarter-quarter sections.
