Ran 14 Jts (447') 9-5/8" OD 32.30# Gr in H-40 SS casing. Set and cemented at 460' with 375 sacks Regular Neat cement. Plug at 445'. Maximum pressure 200#. Circulated approximately 50 sacks cement. Job complete 12:30PM 8-2-54.

After waiting over 24 hours, tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled plug from 445' to 460' and tested below shoe with 500# for 30 minutes. There was no drop in pressure.
