This well was plugged and abandoned 1-24-61. Above casing was left intact. 5-1/2" casing was cemented from 3915-3700' w/30 sacks, and has cement plug from 25' to 0'. We propose to remove dry hole marker, run 2-3/8" tubing with 4-3/4" bit and drill 25' cement plug from surface and 215' (30 sack) cement plug from 3700' to 3915' and clean out to TD of 3935'. Run Gamma Ray-Neutron and Collar Locator Surveys. Perforate with two jets/ft at selected intervals according to logs. Treat perforations with 1000 gals 15% reg. inhibited acid. Run plastic coated tubing with rupture disc on tension packer.
