Total Depth 3870' Dolomite. Ran 93 joints of 5-1/2" 15.50# Grade J-55 casing set @ 3869'. Cemented w/1875 sacks cement w/3% gel preceded by 20 barrels smentox treated water, 2 plug method. Pump pressure 600#, final pressure 1200#. Cement circulated. Plug pumped down @ 9:35 a. m. 4-7-55. Tested casing w/1000# pressure for 30 minutes. Test ok. Preparing to run tubing.
