X-Pert Well Service and Star Tool moved in and rigged up workover equipment. Unseated pump, found rods paraffined up. Rowland Trucking hot oiled rods, down tubing, w/35 bbls. lease oil. TOH w/5-3/4", 148-5/8", and 2" x 1-1/4" x 10' pump (A-1136). Unflanged wellhead and installed 6" 600 BOP. TOH w/125 jts. of 2-3/8" 8rd tubing, 1 jt. of 2-7/8" salt lined, and 2-3/8" SN. TIH w/7" Model "G" RBP; retrieving head, SN, and 123 jts. of 2-3/8" tubing. Set and got off BP at 3,809'. Note: felt tight spot in 7" casing at 1,830'. Displaced and circ. wellbore w/140 bbls. fresh water. TOH w/5 jts. 2-3/8" tubing. Retrieving head at 3,656'. Slurried and spotted 3 sacks on RBP. TOH w/118 jts. of 2-3/8" tubing, SN and retrieving head. Repaired connections on 9-5/8" intermediate casing. Riser in cellar. TIH w/7" fullbore packer, SN, and 59 jts. of 2-3/8" tubing. Packer stopped and unable to work through tight spot in 7" casing at 1,832'. TOH w/1 jt. 2-3/8" tubing. Set packer at 1,808'. Pressure tested casing to 570 psi. Casing held for 30 mins. Tested down tubing to 540 psi. Lost 180 psi in 7 mins. TOH w/58 jts. of 2-3/8" tubing, SN, and 7" fullbore packer. Note: Packer gauge rings measured 6.078" OD. Rings on RBP measured 5.968" OD. TIH w/6-1/8" (Continued On Back)
