FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

A 11" hole was spudded on October 16th and drilled to depth of 1365'. A string of 25.5# Chester casing; 8-5/8"; was cemented at depth of 1364' with 300 sacks of 4% Aquagel cement and 100 sacks of Neet cement. Cement was circulated back into cellar and plug was pumped down at 9:30 A.M., October 19, 1950.

We propose to allow cement a set time of 48 hours before entering hole to pressure test casing.
