8-5/8" 28# 8-thd. New Electric welded casing was set in this well at 2505' and cemented by the Halliburton method with 500 sackd of cement.

Casing and fittings will be tested with 1200# pump pressure and allowed to stand undisturbed for thirty minutes. If no drop in pressure results cement plug will then be drilled out of casing and the same test of 1200# again applied and allowed to stand undisturbed for thirtym minutes. If no drop in pressure results, drilling will be resumed.
