Rig up Schlumberger and perforate 3,804'-3,818', 3,824'-3,837', 3,841'-3,846', 3,850'-3,858', 3,862'-3,870', 3,874'-3,880' and 3,888'-3,896' with 2-1/8" Enerjet Perforating gun with Yper Jet III 2 JSPF (119 total holes). Rig up acid co. TIH with a Sonic Hammer on tubing. Acidize 3,804'-3,896' with 5,000 gals. 15% NEFE DI HCL w/3% DP-77MX. TOH with tubing and tool. TIH with packer and set at $\pm 3,750'$. Rig down acid co. Swab back acid load. TOH with packer and tubing. Trip in hole w/production tubing. Nipple down BOP. Nipple up wellhead. Trip in hole w/rods and pump.
