Casing and fittings were tested with 1200# pump pressure and allowed to stand undisturbed for thirty minutes. No drop in pressur mesulted so the cement was then drilled out of the casing and the same test of 1200% pressure again applied and allowed to stand undisturbed for thirty minutes.
