



Move in and rig up pulling unit. Nipple down wellhead. Nipple up BOP. TOH with tubing. Pick up workstring and trip in hole with tubing and 7" packer to establish rate and pressure. Trip out of hole with tubing and packer. Rig up cementers. Trip in hole with 7" cement retainer. Set retainer at $\pm 2,900'$ and squeeze casing leak with approx. 200 sacks Class "C" cement with 2% CACL. RD cementers. Trip out of hole with tubing. Run in hole with tubing and 6-1/8" bit. WOC 24 hours. Drill out retainer and cement. Test casing to 500 psi. Trip out of hole with tubing and bit. Lay down workstring. TIH with production tubing. Nipple down BOP. TIH with rods and pump. Nipple up wellhead. Rig down and move out pulling unit. Clean and clear location.
