Gentlemen:

Reference is made to your application dated February 6, 1956 for administrative approval of a 640-acre standard gas proration unit. This request was for your Eumont Gas Unit No. 1 Well No. 1, located 2310 feet from the South line and 1980 feet from the East line of Section 4, Township 20 South, Range 37 East, Eumont Gas Pool, Lea County, New Mexico.

Administrative approval is not necessary as this is a standard gas proration unit in the Eumont Gas Pool in every respect. I am returning the original of your application as it is unnecessary.

First, you should submit Form C-103 showing results and tests as outlined on your Form C-102 dated January 23, 1956. Then you will need to submit Form C-104 with gas plat on Form C-128 and Form C-110 and attach a letter to our Hobbs office outlining the approval of communitization of the working interests or attach a copy of the pooled unit as recorded in Lea County on September 3, 1955, that you had attached to your application.

After you have obtained a connection, this well will be issued a 640-acre unit allowable.
