5715' TD - 5713' DOD - Line - Finished drilling 6-1/4" hole to 5715' @ 2:47 P.M., 4-16-54. Ran a total of 66 jts. of 5" OD Liner on 3-1/2" D.P. set @ 5714' and cemented with 175 sacks cement. Pumped plug to 5616' at 1:00 A.M., 4-17-54. Max. pressure 700#. Top of 5" OD Liner at 3648'. After WOC 24 hours tested 5" OD Csg. with 2000# - No pressure drop. Drilled cement from 5349' to 5713' and tested casing with 2000# - OK. Continued with completion operations.
