Pumped plug to 2407' @ 7:40 AM, 3/18/54 - Max Pressure 1050#. Cement Circulated WOC 24 hours. Tested 9-5/8" OD Csg w/1500# before and after drilling cement - OK. Drild cement from 2407' to 2490'. Started drlg formation and 8-3/4" hole @ 8:30 AM, 3/20/54.
