FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Plan to pull rods, pump & tubing. Run Baker retrievable cementer on tubing and squeeze $5\frac{1}{2}$ " casing perf. from 5655'-5786' with 75 sx Reg. Incor cement. Drill out to 5676' & re-perforate Blinebry sone from 5650-5656' and 5670-5674'. Perforate San Angelo zone from 5580-5585', 5594-5596' and 5600-5602'. Run tubing w/ Brown Duo-Pak packer and set @ approx. 5630' w/ PSI nipple on top packer with straight thru tool inserted. Swab the Blinebry natural and if necessary, acidize w/ 500 gals. If does not flow, pull straight thru tool, run blanking tool & acidize San Angelo zone thru perf. 5580-5602' with 500 gals & swab in.
