DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

260' T.D. - Red Bed

Ran 6 joints 13-3/8" OD casing set at 256' with 200 sacks of cement, pumped plug to 244' at 5 AM, 4-7-55 with a maximum pressure of 200#; cement circulated. After W.O.C. for 12 hours, tested casing with 700# for 1/2 hour and held OK. Drilled plug and cement from 243' to 256' and washed open hole to 260'. Started drilling 12-1/4" hole from 260' at 12:30 AM, 4-8-55.
