Spot 10 1/2" x 25' class 'C' neat cement from 2870'-2550'. Spot 1 1/2" 10% acetic acid from 1130'-1088'. Ref. at 1130' w/ 1/4" spf. Pump 9" mud down 5 1/2" prod csg. Set circ out intermediate csg. Pump 125' x 25' class 'C' neat cement & flush w/ 24.5 lbs 9" mud. Left top cement in 5 1/2" at 1030'. Spot 10 1/2" x 25' class 'C' neat cement from 350'-250'. WCC for 2 hrs. Tag TOC at 255'. Spot 10 1/2" x 25' class 'C' neat cement from 100' to surface. Pump 50' x 25' class 'C' neat cement down intermediate surface csg annulus. Rig down.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to well, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
