DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Plugged back in an effort to shut off bottom hole water and installed test pumping equipment as follows:

1. Filled tubing.
2. Ran SIM. Plugged back total depth 3739'.
3. Loaded hole with 40 bbls oil. Dumped 24 gallons hydromite. Plugged back from 3739' to 3723'.
4. Ran tubing. Scrapped well.
5. Set test pumping unit. Recovered all load oil.
6. Pumped 49 bbls oil, 155 bbls water in 24 hours.
