Ran 12 Jts (391') 13-3/8" OD 48# Gr H-40 SS casing. Set and cemented at 408' with 400 sacks regular Neat cement. Plug at 393'. Maximum pressure 200#. Circulated approximately 50 sacks cement. Job complete by Howco 9:30PM 10-1-54.

After waiting over 24 hours, tested 13-3/8" casing with 800# for 30 minutes. There was no drop in pressure. Drilled cement plug from 393' to 408' and tested below casing shoe with 400# for 30 minutes. No drop in pressure.
