There will be three 500 barrel stock tanks and one 500 barrel test tank on this lease with one common separator and one test separator. One well will be kept on test at all times except while test tank is being run by pipe line company.

The wells will be turned into the test system consecutively as numbered, giving us an accurate test of oil produced by each well.
