May 17, 1976 - Cellar was dug out to expose 13-3/8" surface pipe and 8-5/8" intermediate pipe with bradenhead. Surface was piped to ground level with 2" riser and stenciled SUR. Intermediate was piped to ground level with 2" riser and stenciled INT. Cellar was filled with sand to surface. Above work was performed in accordance with NMOCC letter dated May 5, 1976, subject: flow test signed by Mr. Jerry Sexton. Above work was witnessed by Mr. Clements of the New Mexico Oil Conservation Commission.
