TD 2900 - Set 8 5/8" OD casing @ 2900 and cemented with 1500 sacks of cement. Ran temperature survey which indicated top of cement behind 8 5/8" OD casing @ 1120' from surface. Let cement set 48 hours and tested with 1250# for 30 minutes before and after drilling cement plug. No decrease in pressure. Resumed drilling.
