17. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Pulled production equipment. Ran RTTS tool and ret. bridge plug. Tested 7" casing and located leaks between 30' and 64' and between 1096' and 1126'. Spotted 4 sx. sand on top of bridge plug at 3046'. Pulled tubing and pumped 400 sx. Class "C" cement down casing. Cement circulated. Closed Braden head and squeezed Queen gas zone with 50 sx. Class "C" cement. Drilled out cement and tested 7" casing with 1000# for 1/2 hr. QUEEN GAS ZONE P&A.

Washed sand off bridge plug. Ran tubing & recovered bridge plug. Acidized Blinebry zone perforations 5605' to 5700' with 6000 gals. 15% Unisol acid with 475# Benzoic flakes and 450# Moth balls in 4 stages. Swab tested. Reran production equipment.

Well reclassified from dual completed in Eumont Queen gas and Blinebry oil to a single completion in Blinebry oil zone.
