Ran 14 jts 452' 13-3/8" OD 8 RT 40# H-40 SS casing w/ST&C & Larkin guide shoe. Set & cemented at 469' w/475 sacks Reg Neat Lone Star Portland cement. Circulated approx. 50 sacks.

After waiting over 36 hrs., tested 13-3/8" casing w/1000# for 30 min, no drop in pressure. Drilled plug & cement from 410' to 470' and tested formation w/400 psi, no drop in pressure.
