DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was treated with 1,000 gallons 30% commercial Hydrochloric acid solution on February 24th. The well was shut in and left shut in for forty eight hours, until February 28th, when it was scrubbed in. The well was then allowed to flow at its production allowable until the official production test which was made on March 9th. The potential before acid treatment was 746 barrels of oil with 1,000,000 cubic feet of gas. After acid treatment the potential is 1685 barrels of oil with 3,380,000 cubic feet of gas, an increase of 226%. Open flow test through tubing on production test was 1685 barrels. The tubing test of this well was not placed on the tubing-casing curve.
