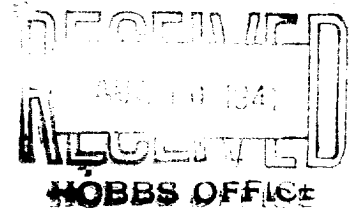

Dear Mr. Yarbrough:

Reference is made to your letter of August 11th
enclosing triplicate Notice of Intention to Drill the
well noted in the caption, with unorthodox location.

Paradoxical as this may seem, the location in
question is within the requirements of the existing
spacing rules insofar as the Hobbs area is concerned.
The foregoing is qualified as follows: Provided the
unorthodox well location is not closer than 330 feet
to any lease or property line or less than 660 feet
from any other well. It is the writer's understanding
that the applicant, the Samedan Oil Corporation, is the
owner of the whole of the NE $\frac{1}{4}$ of the Section involved
and that there is no other well within 660 feet of the
proposed location.

This location is within identical status insofar as
spacing rules are concerned as Samedan - Byers #3, NENE
3-19S-38E.

Said triplicate Notice of Intention to Drill is
