#### DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On July 22, 1945 at 10:00 AM, 96 hours had elapsed since setting 4141 feet of 7" OG J-55 New Seamless casing and cemented with 800 sacks to be used for oil string. Casing shut-off was tested as follows:

A pressure of 550# was built up and held for thirty minutes, and as test was OK, the cement plug was drilled and a pressure of 550# again built up and held for thirty minutes. As this test, too, was OK, drilling operations were resumed.

**Figure 1.** Schematic representation of the experimental design. The first part of the experiment consisted of a familiarization phase during which participants were exposed to the stimuli and practiced the task. In the second block, they were asked to identify the stimulus that had been presented least recently.
