DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On December 24, 1948, at 7:00 AM, 30 hours had elapsed since running 444' of 9-5/8" new casing in subject well and cementing with 250 sacks to be used as surface string. At this time casing shut off was tested as follows:

A pressure of 1000# was built up and held for 30 minutes, testing OK. Cement plug was drilled and a pressure of 1000# was ~~gain~~ built up and held for 30 minutes. This, too, tested OK. Drilling operations were resumed.
