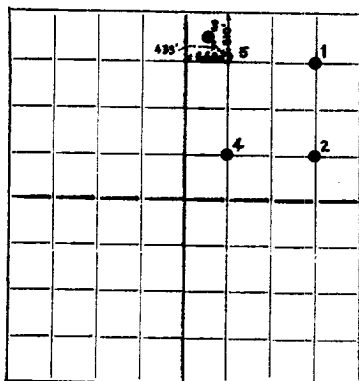

Additional information: (\*) - 433' Southeast of Well No. 3, producing from section 4034/4175' (Hobbs Pool). No. 5, H. D. McKinley (Bowers Field) is to be drilled to total depth of 3215' and produced from the Bowers Sand, the top of which is estimated to be at 3165.
